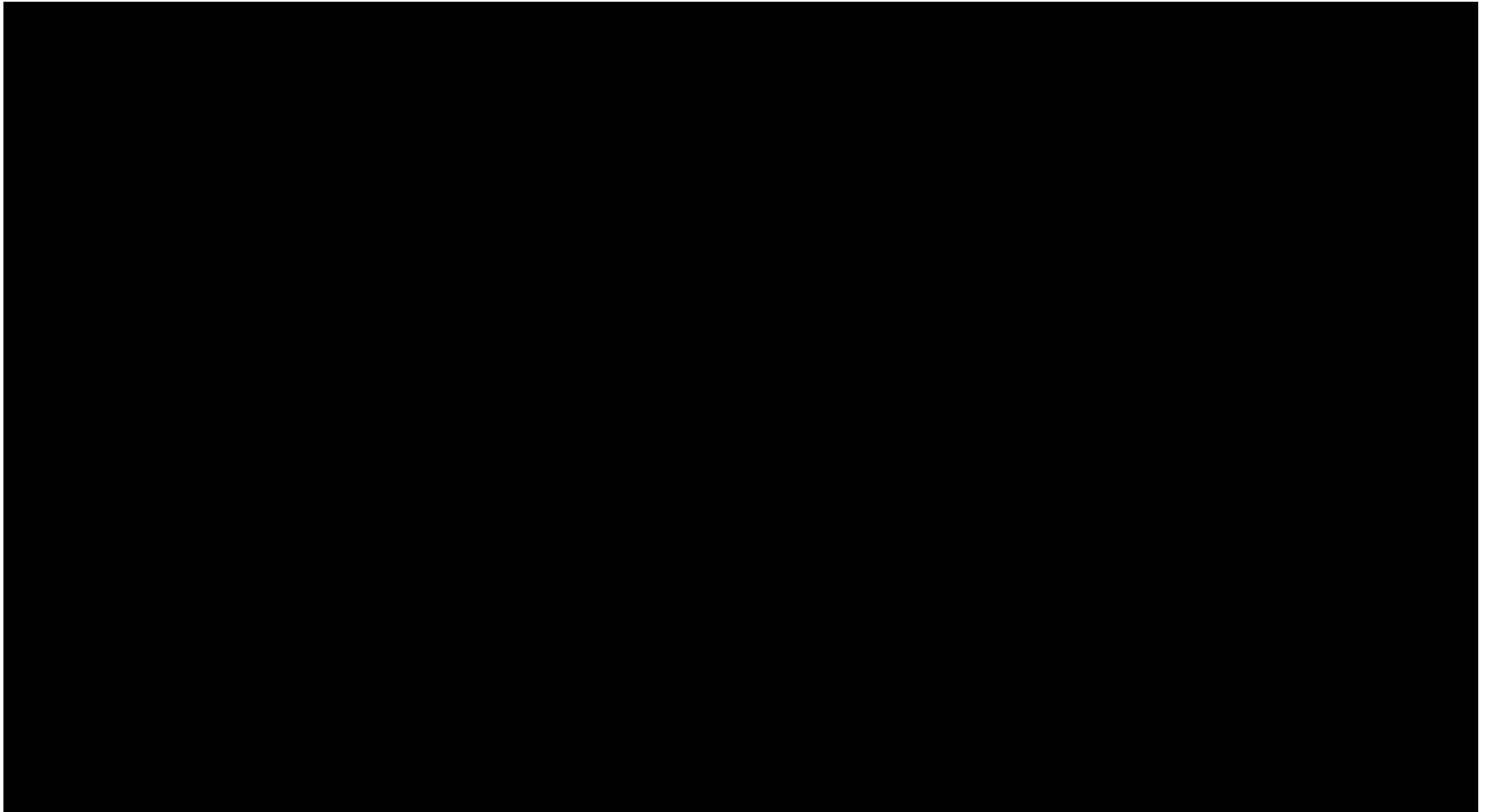

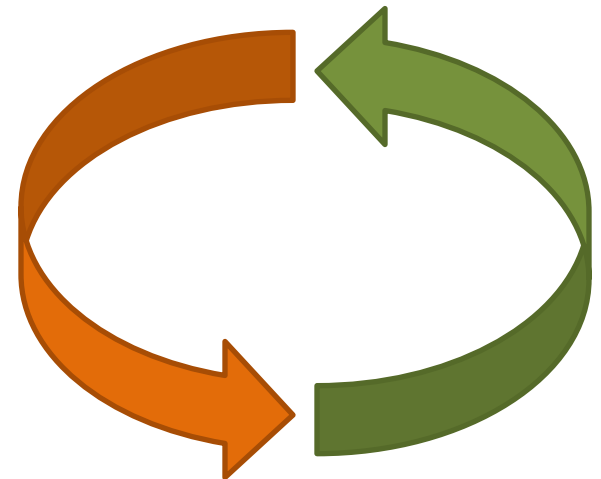

 - The capability of the organization to continue delivery of product or service at acceptable predefined levels following a disruptive incident
 - Best practice in business preparedness
 - Keeps business healthy



Healthy Business



- Mission Essential Functions
 - Identifying priorities
 - Life safety
 - Law, ordinance or code
 - Revenue
 - Impact the community

Healthy Business



	Essential	Non-Essential (during an emergency)
Mission	Respond to emergency fire department calls	Provide community fire prevention education
Support Function	Keep fire trucks operational and ready to respond	Provide retirement guidance to firefighters

- Keeps employees healthy from pandemics, bioterrorism attacks

Can your business survive?

During a public health emergency like a large scale biological attack or a naturally occurring pandemic, Maricopa County Department of Public Health can open points of dispensing sites to quickly provide life-saving medications that prevent illness and death to the public.

30-40% of employees will leave work due to illness or an ill family member

Open POD: 1-2 day disruption



Employees leave work to pick up lifesaving medications at a public location
Business is disrupted for days
Community impact is high



Closed POD: hours disruption



Employees stay at work
Medications are delivered to your business
Business disruption is minimized
Community impact is low



Benefits to being a Closed POD Partner



Business Continuity

- Minimal disruption of day-to-day operations
- Company continues to perform essential services
- Helps with business recovery after a public health emergency



Corporate Social Responsibility

- Reduces the number of people at Open PODs
- Reduces the impact of disaster at the local community level



Employee Wellness

- Employees get life-saving medications at work
- Enough medications for all family members

Closed POD Critical Partner



Municipalities, Hospitals, Utilities and other critical infrastructures:

- Provide life-saving medications to employees and some clients during a public health emergency
- Keep important civil services running
- Enhance their continuity of operations plans

Volunteer Partners support public health emergencies in Maricopa County

- Dispense life-saving medications at PODs
- Manage call centers in the Public Health Incident Command Center
- Participate in preparedness events year round

Open POD Partner

Schools, Churches and Community Centers:

- Plan with MCDPH to dispense life-saving medications in their neighborhoods
- Open their doors to the public during emergencies
- Volunteers provide supplemental staffing



Closed Community POD

HOAs, Closed or Masterplan Communities

- Work with MCDPH to plan for public health emergencies at the local level
- Run Points of Dispensing in their neighborhoods and communities
